

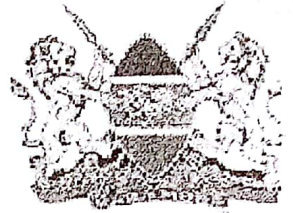

FRAMEWORK AGREEMENT EXTENSION FOR 1 YEAR (2024-2025)

FOR

SUPPLY AND DELIVERY OF FUEL, OIL, PETROL, AND LUBRICANTS

BETWEEN THE

AND

M/s. NASROS ENERGY LIMITED

THIS AGREEMENT is made on 12TH day of NOVEMBER, 2024. BETWEEN THE COUNTY GOVERNMENT OF MARSABIT (hereinafter referred to as the "Procuring Entity") and having its principal place of business at MARSABIT TOWN, GOVERNORS' OFFICE BUILDING and of P.O Box 384-60500, Marsabit (hereinafter called "Procuring Entity"), of the one part;

AND

M/s. NASROS ENERGY LIMITED, a corporation incorporated under the laws of Kenya and having its principal place of business at TOWN area within Marsabit/ and of P.O Box 384-60500, Marsabit, of the other part.

In Consideration of the mutual covenants contained in this agreement, the parties agree as follows:

WHEREIN said Agreement expires on 14TH NOVEMBER, 2024 and the parties desire to extend and continue said agreement; it is provided that the said Agreement shall extend for an additional term of 1 (one) year, commencing upon the expiry of the original terms and expiring on 14TH NOVEMBER, 2025.

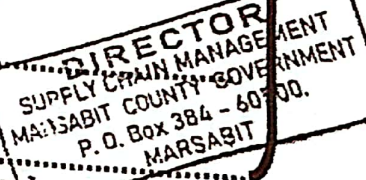
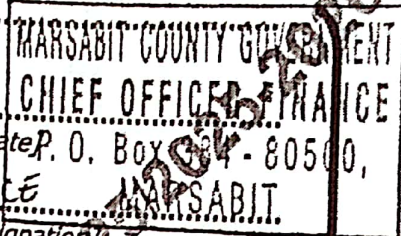
