Proof of registration and technical experience is required.
1.2	A Tenderer with an ongoing project within the school which is behind schedule and without an proved extension of time SHALL NOT be eligible to submit a tender .
1.3	Selected Contractor shall enter into legally bending contract with the Institution by signing Contract Agreement specifying the agreed Price and the completion Period .Technical working drawings are appended to Bills of Quantities where applicable.
1.4	Contractors should understand that the work is urgent and is advised to prepare and attach during submission of Tender document the Work Schedule for this project indicating the Start Timeand End Time .
